## Called to order at 7:01PM

- Welcome and Introductions
  - Roger offers an opening statement about mission of FRCC
  - Matthew Coleman offers Army Corps of Engineers "Colebrook Dam 101" slide show.

- Q&A with guests from the Army Corps of Engineers at Colebrook Lake Reservoir
  - Conversation recorded and posted to FRCC website.
    - Major points:
      - MDC and USACOE are in daily communication via the Reservoir Control Center to make decisions in concert.
      - USACOE is constantly monitoring USGS gauges on the river as well as the potential for incoming precipitation from the National Weather Service.
      - USACOE has limited ability or authority to proactively release water ahead of storms because pools below 708ft mark in reservoir are under control of other agencies.
      - Releases after rain events are determined entirely on down stream stretches of the West Branch Farmington to pass flows without flooding towns.
        - The max they are capable of releasing is 3000 cubic feet per second (cfs). USACOE has never reached that maximum.
        - Releases are typically ramped by 300cfs per hour.
      - USACOE purpose is to attenuate the natural peak of what would otherwise be a flow that would result in flooding.

- MDC's Hydroelectric Facility at Goodwin Dam is not a FERC licensed facility. This facility has a FERC Exemption From Licensing.

# **Unplanned conversation Re: River Flow**

Alicea Charamut, Rivers Alliance CT – Dispute is about leverage for MDC not the money they have to pay ACOE. Fear that taxpayer money would be used to get MDC out of contract and thinks it will take an act of congress to get MDC out of the agreement.

Jim Randazzo, MDC – Why should MDC's water customers pay for water storage space in Colebrook that can never be used for public drinking supply based on public opposition and CT DEEP Diversion Regulations. Clarification: The 10 Billion Gallons (BG) is water storage space, not actual water; it is the right to store 10 BG of water. Hypothetically, if some natural disaster damaged the Colebrook Dam, and the needed repairs cost \$40 million, MDC's water customers would be on the hook for 35 percent of that.

Alicea Charamut, Rivers Alliance CT—Just wanted to know that Rivers Alliance thinks MDC methods are the problem not the reasons why they needed to get out

James Jykkla, ACOE – In not calling for releases, are there any estimates for how much money MDC is not earning from hydro power production.

Jim Randazzo, MDC – Hydro revenue has lately taken a down turn in a sense because MDC is sometimes limited in its ability to generate hydropower when the Corps is conducting flood control operations given all the precipitation we've been getting lately. Basically missed opportunity. No cost estimate. MDC's position is that in releasing its rights to the 10 BG storage space in Colebrook it will still run hydro the best it can at Goodwin using the reserve of 3 BG behind Goodwin and 3.5 BG behind Colebrook as available during dry years
