# Organization Updates

#### • MDC

- A schematic drawing for the water allocations in Colebrook River Lake was distributed to the committee prior to the meeting
- Neither Howells Brook nor Thorne brook are monitored by MDC. They flow into the spillway and not the reservoir

#### CT DEEP

- The review of the proposed Inland Sports Fish regulations package has been delayed. The
  proposed changes will not be implemented on the original target date of January 1, 2025.
   Because hard copy booklets are distributed, the earliest for the implementation of these
  proposed changes will be January, 1 2026
- The riverside survey being conducted by DEEP will conclude at the end of 2024. Data will be available in 2025
- The draft of the flow plan, as stipulated in Section 2 of PA 24-13, is still under review. DEEP will
  reach out to stakeholders for review of the plan

#### NPS

- Aimee Petras (FRWA) joined Laura and Andrew at NPS' biannual wild & scenic partnership conference in October
- NPS' Water Resources Organization has added the Upper Farmington River to their list of organizations to possibly support
- Last minute funding from one of the federal bills for aquatic activity. Dam removals is one way to use these funds. NPS staff is looking at what would be in the pipeline
