**Budget**: Looked into what we had to move over in E&O budget line items this past fiscal year to help us better plan for 2026 workplan. Mainly, mileage reimbursement category for River Stewards. Upped River Steward program from \$56,000 to \$60,000, and increased Outreach to \$3,000, noting most grant proposals coming to E&O would be from the Grants budget. All are in favor of proposed draft.
