#### Invasive Plant Management

- All Habitats quotes for treating bittersweet and other invasives as defined in the quote. Quotes were submitted for treatments in People State Forest and Nepaug
  - Approval for the People State Forest quote of \$16,000
  - Motion: Dan

  - Discussion: We will only vote for the treatment in People State Forest, not Nepaug.
    Treatment of the invasives in that section of the river could be revisited in August.

  - Laura met with New Hartford government leadership, Dan Jerram (1<sup>st</sup> Selectman) & Christine Hayward (Admin Asst to 1<sup>st</sup> Selectman). They support the removal of the culvert, but share the same concern which has been expressed before, how to access the site of the culvert

### Town Updates

- Barkhamsted: Planning & Zoning approved the special exception for the property on River Road for the construction of a contractor shop, with storage and outside storage. <u>Barkhamsted</u> <u>Planning & Zoning Minutes 03/13/25</u>
- Canton:
  - There is a proposal for a gravel strip mine in town. The town is working through the legal process
  - Town budget meeting FRWA support was raised in the meeting
- Colebrook: None
- Hartland: None
- New Hartford: None

### Organization Updates

- MDC: Elevation of Colebrook 675 feet. It is low
- CT DEEP:
  - Opening day of catch & keep is April 12, 2025
  - Bank stabilization project in Barkhamsted. Princton Hydro submitted the packet on behalf of the town. Andrew to contact town first selectman to confirm they support the proposal
- NPS:
  - o Continuing Resolution for federal funding passed and is effective through September
- FRWA:
  - Tree planting on March 28 & 29
    - Frey Property in New Hartford
    - FRWA and TU project, funded by the National Park Service
- FRAA: None
- FVTU:
  - DOT guidelines for the application of herbicides and road treatments along wetlands and waterways to be shared with the FRCC full committee

- High Tech Hobo prefab is underway
- TU national is concerned about the ongoing funding of \$180MM in federal grants
- CT TU submitted testimony on riparian buffer bill HB7174
- River Stewards:
  - Monofilament signs were delivered
  - Trail counters on waterways are not recommended. Changes in the height of the water and the glare off of the river result in false counting
  - Interviews for the River Steward positions are underway. Official last day for applications is the end of March
