 - Joint display of the quilts at Kingswood School in West Hartford in September

- New Hartford River Rocks at Hurley Business Park, June 21
- June – DEEP/FRCC/Legislators paddle
 - DEEP to secure some boats
 - Possibly June, after the legislative session: June 23, 25, 26, or 27
 - Tentative: Church Pool to Satan's Kingdom

River Stewards

- 3 previous River Stewards to return, 3 new River Stewards - 6 total.
- May 31st is the first day, training at Squires Tavern

Other

- Leave \$300 for FALPS final tree planting grant (return rest). \$1,191 remained unused from the tree planting grant. \$300 was retained to cover the cost of a bronze plaque being planned to commemorate the centennial oak; the balance was returned.

Resource

Invasive Species Management

- All Habitat Service has started painting and cutting in approved sections in People's Forest
- Autumn Olive has been identified as remaining in the area not yet cleared
- The company is planning on removing it

Water Quality Monitoring

- Water Quality Monitoring is ongoing
- All data loggers are being swapped out and data is being downloaded
- New loggers have been placed in new locations
- Summer monitoring begins May 19th

Land Protection/Grants

- No land protection grants were received

Culverts

TU submitted an estimate for the Ratlum Brook Reconnection Project to mitigate the impaired culvert presenting a barrier to the Eastern Brook Trout. The requested amount of \$15,500 includes:

- Data summary, sub-watershed assessment and map of watershed
- Monitoring plan and 1 summer monitoring data collection

- Watershed wide road crossing survey and management recommendations
- One priority conceptual level culvert and dam removal and restoration design and cost estimate; culvert removal to include cost comparison between replacement and removal
- The project includes monitoring:
 - Develop a river specific monitoring plan
 - Work with CT DEEP Fisheries staff to collect fish data in the watershed
- DEEP & Army Cops involved
- This plan considers a restoration and not a replacement of the culvert and the dam
- A NFWL grant will be submitted after the plan
- Vote
 - Motion: Alison J
 - 2nd: Matt
 - Discussion: Multiple private landowners are listed in the documents which were distributed but only one private landowner would be impacted by the proposal
 - The town of New Hartford supports the removal of the culvert and the private landowner supports removing the dam downstream from the culvert
 - There was consideration to include another culvert and dam in this project. They are on private land and the landowner didn't approve access to their land
 - Vote: Motion passes unanimously

Hobo

- FVTU & FRAA installed the high-tech hobo behind Upcountry
- Exploring an easy way to share the data
- Some of the sensors are not working and are being addressed
- The conductivity and pH readings are being reviewed for accuracy

New Business

Japanese Knotweed

- Colebrook is working with the town DPW to address this invasive in their town
- There is an initiative to organize a muti-town group in the Upper Farmington River
- They are looking for a rep from Barkhamsted
- Towns would do the mapping of Japanese Knotweed

- Hartland: Dan B. met with Maggie Winslow, Frist Selectwoman, and provided an update on FRCC
- New Hartford: Conservation Commission is being reincarnated

Organization Updates

- MDC: Not present
- CT DEEP:
 - Riverton Fishing Derby
 - 75th Annual Riverton Fishing Derby was held on April 12th
 - Pete A. represented DEEP
 - Legislators Anderson & Honig attended
 - Yearlong survey/interviews
 - Staff is pulling together the data
 - The results could possibly influence regulation changes in 2027
 - It has not been published
 - Farmington River Flow Management Plan
 - Adjusted based on feedback
 - DEEP internal review completed, including commissioner sign off
 - Currently with the Office of Policy and Management for review
 - Colebrook is full – looking to maintain it close to 708ft
 - Needs to be below 708 after July 1
 - Hatcheries budget was restored in the current proposed budget
- NPS:
 - Staffing assignment for each W&S river is being reviewed
 - Westfield Wild & Scenic Committee
 - Road salt reduction campaign. They would be a good resource. Similar to Green Snow Pro. The main additive is molasses!
 - CT law - the road has to be melted within 24 hours
 - W&S coalition advocacy efforts [Home - Wild and Scenic Rivers](#)

- FRAA: Rainbow trout were stocked in the Upper Farmington
- FVTU: Provided written testimony for the Riparian Buffer Bill (HB7174)
